



Print Image Claim Editor vs. NET Correct Claim Editor **NetCor**

The **NET Correct** Claim Editor and the **Print Image Claim Editor** can not be used to edit the same claim. If a claim is edited online using the [Print Image Claim Editor](#), each new version of the claim after that which is rejected, re-edited online and resubmitted online will have to be edited using the Print Image Claim Editor. The [NET Correct](#) editor will not be available for use on claims that were originally edited using the Print Image Editor. The same is true if the claim is first edited in NET Correct. All future versions of the claim will then need to be edited in NET Correct and the Print Image Editor will not be available for editing a new version of the same claim.

However, this will not apply to claims that are re-transmitted to [Infinedi](#) from your Practice Management software. If you elect to re-transmit your claim rather than correct it online, this will reset your options to use either editor. Likewise, you will need to commit to using one editor or the other for editing this new claim.


